NOTICE OF LISTING OF PROPERTY OF INTEREST (Sections 8(5) and 8(6) of the National Trust of Trinidad and Tobago Act, Chap. 40:53)

POINTE-À-PIERRE WILD FOWL TRUST

Take notice that the National Trust of Trinidad and Tobago with the approval of the Minister of Planning and Development has listed **Pointe-à-Pierre Wild Fowl Trust** as a property of interest in accordance with section 8(2) of the National Trust of Trinidad and Tobago Act, Chap. 40:53 ("the Act") by list dated 6 November 2019, published in the Trinidad and Tobago Gazette No. 173 Vol. 58 dated Thursday 5th December 2019. This property of interest is located on 32.1652 ha of land situate in the Ward of Pointe-à-Pierre and is more particularly described in the aforementioned publication of the Trinidad and Tobago Gazette.

The **Pointe-à-Pierre Wild Fowl Trust** has been listed as a **Grade C** property of interest. In this regard, please note the following:

The National Trust Regulations defines a Grade C property as a "a site or place which contains or breeds a particular specie of plant, animal, bird, fish, insect or marine life, that is likely to be despoiled by the introduction or removal of any, or all, or a combination of, the species present, or by the introduction of any new specie" (Regulation 3(3)(c)).

You are asked to note that under section 27 of the Act, a person who alters, damages, injures, or defaces any listed property or demolishes or destroys or causes to be demolished or destroyed any listed property otherwise than in accordance with the written permission of the Council, commits an offence and shall be liable on summary conviction to a fine of five thousand dollars and the Court may also order that person to pay the National Trust of Trinidad and Tobago the cost to repair or restore the property.

This notice is given to you as the person known to be the owner/person in possession of this property of interest. Please note that the listing of this property became effective on the above-mentioned date of publication in the Trinidad and Tobago Gazette.
